- \*\* Catoosa The Nutrition Center: 5238 Evett St. Take Hwy. 41 south through Ringgold. Go under railroad overpass and turn left. Located next to the Fire Hall.
- \*\* Dade County Justice Bldg.: 75 Case Ave. Take I-75, Hwy. 136 or Hwy. 11 to Trenton. The building houses the Sheriff's Dept. The class is held in the small courtroom.
- \*\* Chattooga County Annex: 120 Cox St. Take Hwy. 27 to Summerville. Turn west onto Washington St. at the main courthouse. The annex is the first building on the left after the Sheriff's Dept. The class is in the small courtroom.

### About TransParenting™

TransParenting™ is an educational program designed to teach effective parenting during the transitions of divorce and parental separation. This is an educational program and NOT a counseling session. Parents will not be expected to discuss personal issues.

The seminar emphasizes each parent's responsibility to provide a nurturing, non-threatening environment for the child.

#### Topics include:

- \* Feelings associated with divorce.
- \* Ways that children of different ages react during transition.
- \* A parenting approach that will benefit your children.
- \* Suggested ways for talking to children about divorce.
- \* Other adjustments children will need to make.

The course is taught by professionals who have experience with children and who have been specially trained by the program creator and owner, Families First, to teach the class.

### Attendance

Attendance at the class is required for all parties to a case where the interests of children under the age of 18 years are involved. The court's action on a petition will not be delayed by a non-moving party's refusal or delay in completing the class.
