STANDING ORDER ADOPTING LOCAL RULES

The undersigned Judges of the Superior Courts of the Lookout Mountain Judicial Circuit (hereinafter the "Judges) enter this Order to adopt local rules pursuant USCR 1.2(B) and (E).

The Judges have previously, by Standing Order, provided for the procedures to be followed in the Circuit. However, in an effort to simplify and update the procedures, the Court has created local rules which are publicly available on the Circuit's website and which language is easily accessible to all litigants.

These Rules, as amended, shall be published on the publicly available website. All Parties and Counsel are bound by the Rules and are expected to abide by them under penalty of contempt. There is no requirement of further notice or service except for service of the Domestic Relations Standing Order.

All Parties and Attorneys for all Parties are expected to be familiar with the Local Rules and the Uniform Superior Court Rules applicable in their case.

The Judges of this Circuit strongly encourage all litigants to seek legal representation. Self-Represented litigants may find resources on the website of this Circuit and other Circuits in the State of Georgia, but the Court, and the Court's staff, and the staff of the Clerk of Court may not provide legal advice.

It is, therefore, ORDERED:

The Local Rules attached hereto shall be the operating procedures of the Superior Courts of the Lookout Mountain Judicial Circuit. The Local Rules set forth in the Standing Order supersede all previous Local Rules established by any previous standing order.

The Clerk shall spread this order upon the minutes.




