PRE-TRIAL CONFERENCE/ORDER

TO ALL PARTIES AND COUNSEL OF RECORD:

In compliance with section 7.1 and 7.2 of the Uniform Court Rules of the State Courts of the State of Georgia, you are hereby ordered to prepare and submit a proposed consolidated pre-trial order to the Clerk of Court, with a copy to Judge Ronald C. Goulart, 875 Lafayette Street, Ringgold, GA 30736, on or before **October 6, 2026 at 5:00 p.m.**, in the following attached cases. Mailing said order on or before said date shall not constitute compliance with this order. The Judge's copy may be mailed or hand delivered by the above-mentioned deadline.

Violation of this order will result in the imposition of appropriate sanctions. The Uniform Court Rules of the State Courts of the State of Georgia are hereby made a part of this order.

It is ordered that trial counsel or a pro se party shall attend the pre-trial conference scheduled for **October 9, 2026 at 10:00 a.m.** in courtroom A at the Catoosa County Courthouse.

If any case has been settled, file the necessary order of final disposition with a copy to Judge Goulart.

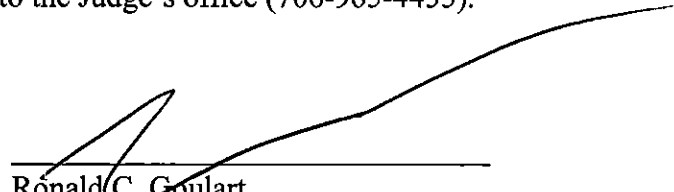
If the parties are unable to file a consolidated pre-trial order, the parties are ordered to prepare a proposed pre-trial order.

All pending motions should be disposed of by the time the consolidated pre-trial order is due, or an oral pre-trial hearing shall be scheduled, so that all pending motions can be disposed of before the case is set on the trial calendar. Oral pre-trial hearings, if necessary, will be scheduled at the pre-trial conference. **No case will be placed on the trial calendar until mediation has been completed.**

A final jury trial calendar will be prepared and furnished to counsel of record/pro se parties upon completion of pre-trial conference and hearings. Jury trials will be scheduled for November 9, 2026 thru November 13, 2026.
